2-METHYL-4-ISOTHIAZOLIN-3-ONE	Asthma-like symptoms may continue for months or even years after exposure to the material ceases. No significant acute toxicological data identified in literature search. The material may be irritating to the eye, with prolonged contact causing inflammation. The material may cause skin irritation after prolonged or repeated exposure and may produce a contact dermatitis (nonallergic). NOTE: Substance has been shown to be mutagenic in at least one assay, or belongs to a family of chemicals producing damage or change to cellular DNA.
